Of all the animals who share this planet with us, the horse is one of the most powerful and yet gently gracious animals with whom we interact.



However cruelty, normally through sheer neglect, does not escape these noble beasts and they can be reduced to feeble frames and left in paddocks to suffer.

In 1990 the International League for the Protection of Horses was established in New Zealand to act as an equine lobby and welfare protection group. An affiliation existed with the ILPH in England which was founded in 1927

with its principle objective being to prevent ill-treatment of horses being transported to Europe. With the demise of that International association the ILPH in New Zealand has now become affiliated with the SPCA in Auckland. Whilst it still retains its autonomy its horse welfare activities will now include law enforcement capabilities through the warranted inspectors with the Society.

Their continuing work will include investigations, adoptions of rescued horses, ponies and donkeys, lobbying to improve legislation and codes of practices related to equine welfare, and the provision of professional and practical advice and assistance as required.

HOW YOU CAN HELP THE HORSES
